AND I DECLARE that whatsoever that my attorney should do or perform to be done by virtue of these presents **I HEREBY AGREE** to allow ratify and confirm. **I ALSO DECLARE** that this authority shall be deemed to remain in full force for a period of five (5) years unless sooner revoked by me in writing and if monies held by the Land Trust Division of the High Court at Rarotonga are the subject of this authority, in whole or in part, then a copy of the note of revocation shall be delivered by me to the Registrar of the High Court by way of email, facsimile, delivery or post.
